6. Buyer transfer fund via MT 103 upon successful dip test and title passes to the buyer
7. Seller loads the product to the buyer designated vessel as per INCOTERM 2000 FOB/CIF.
8. Shipment commence as stated in the contract.
9. Intermediaries are paid for each lift for the signed contract and for roll-overs.
